


TET & COMS

- Boskalis created a Travel Emergency Team (TET)
- This team is to advise, coordinate and support project teams and vessels on travel related matters during the COVID-19 outbreak
- Frequent videocalls with project teams and vessels
- Pre-travel arrangements (extensive concepts)
- (Charter) flights
- Boskalis TET implemented temporary 'COVID-19 Outbreak Management System' (COMS)
- This system includes a complete and clear set of management documents which will guide vessels and project sites in managing the COVID-19 crisis.
- The above procedures are intended to increase the safety of all crew members & project staff



Boskalis COMS Travel App

- The App can be used by all Boskalis colleagues as well as external hired employees
- This app/ documents provides instructions on necessary precautions that must be adhered to when employees are traveling to a vessel or project site.



- Home Stay (Self quarantine) Prior PCR Testing
 - 7 days before traveling to vessel or project site crew members and project staff to apply selfquarantine at home
 - Always remain in your place of residence during the 7-day period.
 - Do not leave your residence, not even for purchasing food and essentials.
 - Inform your family and friends that you have a stay home period.
 - Minimize contact with others and avoid having visitors to your residence.
 - During home stay it is necessary to fill out daily registrations
 - Travel Health Declaration Form;
 - Certificate of Medical Fitness;
 - Daily registration 7 (or 14) days;

- PCR Testing prior departure
 - The objective of this procedure is to be prepared for and to control the spread of the Corona virus.
 - Early detection, prevention and control of COVID-19 of those who signon is important to be able to protect the health of all crew members and project staff and to avoid transmission of the virus
 - All travelling employees receive instructions from the crew-coordinator to go to a specific testing location (e.g. Corporate Travel Clinic)
 - The test results process may take up to 24 hours. Employees must remain isolated in a designated departure hotel (e.g. Ramada Hotel or Mercure Hotel) during the time of the test results processing.


- Instructions during flight
 - The general recommendations from WHO to be applied
 - Travel Kits COVID-19 are supplied by Boskalis in The Netherlands at home addresses and/ or provided at the designated departure hotel.
 - Face masks
 - Gloves
 - Hand cleaning gel
 - Thermometer



- Upon arrival
 - All employees must have approval from MTI (Ministry of Trade and Industry) and MOM (Ministry of Manpower) before entrance.
 - Predetermined Quarantine Order Hotel transport



- Quarantine Order of 14 days
 - Homer Mobile Application
 - Thrice daily reporting:
 - Selfies
 - Temperature check
 - Answer 5 questions (if you have fever, cough, sore throat, running nose, etc.)
 - MOM (Ministry of Manpower) check-up calls
 - PCR Test after 10 days





Boskalis Quarantine Support Team

To improve/ maintain the psychological and social well being of our Staff and Crew.

- Quarantine Portal: A portal full of relevant information, FAQ and entertainment
- Quarantine Box: Contains a tablet for those without a laptop, local telephone, sport articles, local Netflix account, Boskalis goodies, local information and more
- Close connection: Participate in online meetings with the project team or vessel to stay connected
- Social events: Daily digital coffee with the project team or vessel
- Stay Fit and Healthy: Digital sport exercise sessions guided by a personal trainer
- Learning and development: Access to Boskalis Online Academy
- And more services like the 'Yourizon', SPWO pastor and the '24/7 lifeline'



Working in Singapore (Project Site)

- Daily temperature check + Trace Together Mobile Application
 + Bluetooth device wristband
- Employees to undergo Rostered Routine PCR Testing (RRT) every 14 days
- Cohort and isolate working groups (e.g. each dredging vessel)
- Telecommunication is the default
